Please see Eileen Sciscoe's important article regarding the Structural Integrity Act/ reserve funding law that was signed by Governor Murphy in January 2024.

This law is a result of the catastrophic 2021 collapse of the condominium towers in Surfside Florida. This new law in NJ mandates structural inspections, reserve studies, and reserve funding by all community associations, and was intended to ensure those communities are financially secure and structurally safe. Legislators say this Act applies not only to condo associations, but to private lake communities like us! As a result, LCPOA will be required to substantially increase your dues (see my previous newsletter articles for details). So LCPOA has been contacting our legislators requesting they improve this law to provide relief for HOA lake communities with private homeowners, such as you! Eileen's newsletter article will give you details on how you can help!

Last but not least, our next General Meeting is scheduled for Weds April 30<sup>th</sup> at 7:30PM. General Meetings are crucial for keeping LCPOA's business moving forward, and also serves to update our members on what is happening in the community. We urge you to attend!

Board members are volunteers, meaning they serve without pay or compensation, and are elected by the members of our community. Unlike employees or hired professional property management companies in many other private communities, LCPOA board members do not receive a salary or any other form of monetary compensation for their services. Board members share their spare time and expertise to manage LCPOA's affairs for you. So these meetings are your opportunity to address questions to the Board, and provide us with your feedback on any recent changes or updates that have already been implemented.

More importantly, clearly displayed house numbers are critical in emergencies for police, fire, or ambulance services. Let's work together to keep everyone safe and accessible.

With the assistance of Senator Space we can now dialogue the Honorable Troy Singleton-Chairman, Senate Community and Urban Affairs and the Honorable Yvonne Lopez-Chairwoman, Assembly Housing Committee. Both of which have introduced bills into the Senate and Assembly, that could remove us as being described by Condo requirements. We need your help to get these bills heard and voted on! ## ***DUES***

***DUES PAYMENT:*** The **THIRD** quarter payment is due by **June 15**. This payment will receive a late fee if it is not received in the office or postmarked by July 1st.

## ***GARBAGE CUTOFF***

**May 14-** Your Trash Service will be interrupted if your Second Quarter dues have not been paid.

**July 16 -** Your Trash Service will be interrupted if your Third Quarter Dues have not been paid.

Please remember that you can drop off your payments in the drop box by the front door of the clubhouse, and we accept payments over the phone by credit or debit card.

## ***DISCOUNTS***

Members are only eligible for one of the following discounts:

### ***SENIOR CITIZEN DUES DISCOUNT***

Members who are 62 years of age or older are eligible for a 10% discount on the Dues. You must provide the office with proof (such as a driver's license or birth certificate) to receive the discount. This discount will not be applied if the account is currently receiving the 10% Vet/Active Military Discount.

### ***VETERAN/ACTIVE MILITARY DUES DISCOUNT***

Members in good standing that are veterans or active military shall be offered a 10% discount in their yearly dues. Proof of service must be provided. This discount shall not be applied if the account is currently receiving a 10% Senior Citizen Discount.

## BEACH RULES

**Guests & Guest Passes:** Guest passes will be issued up to ten (10) guests per family with a refundable deposit.

1. A member NOT in good standing may NOT be a guest of a member in good standing.
2. Other non-members as described in the CONSTITUTION, ARTICLE III, Section B, may NOT be guests.

**PETS:** All pets must be properly licensed in accordance with the Vernon Township ordinances and must be leashed at all times. **NO** pets will be permitted in the beach area at any time.

**Beach & Boating Safety:** No fishing or boating at any time will be permitted in the designated swimming areas. All N.J. State boating regulations will be adhered to. No motors other than a battery powered trolling motor will be permitted on any lake in the L.C.P.O.A.
