#### SCOTT GHYSELS PRESIDENT

Welcome to our summer newsletter! We hope you're enjoying the sunshine and warm weather. This edition includes important updates and community news. Join now and never miss out! Thanks to our recreation director Susan Blanchard and all who helped with our Summer Kickoff on the beach on June 21<sup>st</sup>. It was a wonderful way to kick off the summer!

Our lake waters look great, thanks to our new lake management vendor! Maintaining good water quality is essential for a healthy and aesthetically pleasing environment for our members to enjoy. Lake water management is a science including not only water quality, but aquatic vegetation, fish populations, ecosystems, etc. LCPOA is responsible for the upkeep and management of all common areas and elements, including our lakes. This responsibility is a fundamental part of the Association's role and is outlined in our governing documents. Common areas include properties, spaces and amenities shared by all members, such as our roads (including LCPOA) paper roads!), lakes, dams, beach area, playgrounds, clubhouse, etc. Your dues are the primary source of our funding for common area maintenance. Individual members have a shared ownership interest in our common areas but not exclusive control. Any unauthorized use of and/or encroachment upon our common areas by individual LCPOA members can lead to consequences like fines, restrictions, or even legal action. The LCPOA board is responsible for all common areas and elements.

Dumping is illegal in New Jersey and is taken very seriously! Violators can face significant fines, potential jail time, and other penalties. Illegal dumping refers to the act of disposing waste without permission in unauthorized locations, such as on public lands or on LCPOA properties. Waste includes everything from leaves to small amounts of trash to large

quantities of debris like construction waste or even discarded boats. LCPOA has installed numerous security cameras, and we will contact the authorities if someone is illegally dumping, and we may pursue legal action. Plus Wawayanda State Park surrounds Barry Lakes, and New Jersey is now also actively combating illegal dumping on NJ state lands. The Department of Environmental Protection (DEP)'s "Don't Waste Our Open Space" initiative was begun to deter illegal dumping and protect natural resources. So State Park Police & Conservation Officers are out in full force, and perpetrators can face fines up to \$50,000 and arrest.

It has been the longstanding position of the LCPOA board that maintaining road drainage swales are the responsibility of the homeowner where the swales are located between a roadway and the home owner's property. This includes tasks such as removing vegetation and debris such as leaves, branches or any litter found in the swales. These responsibilities are part of the rules & regulations voted upon by the Board and published in previous newsletters. The LCPOA board has the authority to impose rules and regulations, as outlined by our governing documents. If however a swale fails for any reason, other than it not being properly maintained by the homeowner, please contact the LCPOA office so it can be inspected. The LCPOA will take action to address any issues that are not due to lack of maintenance. See our legal director (Mark Whitman)'s article for more on this topic.

The Barry Lakes beach is private and for members in good standing only. Beach Badges must be worn at all times. Guest passes are available at the clubhouse. But anyone who is not a member in good standing, or who does not have a valid guest pass, will be asked to leave. It is considered trespassing if a person who is not a member uses our lakes or beach (or any other common areas). Therefore LCPOA can charge those violators with trespassing. Parking permits must be visible on all vehicles parked in the beach parking lot. Please do not park in the Fire Lanes or block access lane to the lakes.

Be advised New Jersey has a new mandatory cold weather life jacket law; Between November 1 and May 1st, anyone using rowboats, canoes, kayaks, or stand-up paddleboards (basically all recreational vessels under 26 feet) must now wear a securely fastened, U.S. Coast Guardapproved life jacket. Why Is This Law Important? Cold water significantly increases the risk of hypothermia and drowning. Even strong swimmers can lose mobility within minutes of falling into near-freezing water. For example just this past April, a 55 year old Denville man drowned after flipping his kayak on Cedar Lake. Sadly he was not wearing a life jacket.

In January 2024, Governor Phil Murphy signed new legislation in NJ called the Structural Integrity Act, designed to protect the structural integrity of condominiums and cooperative buildings in response to the June 2021 collapse of the Champlain Towers South beachfront condominium in Surfside,

Florida. Unfortunately, this legislation was written so broadly that it applies to all planned real estate developments in NJ, which includes HOAs and private lake associations such as LCPOA. This law implements capital reserve study requirements to ensure common interest communities maintain adequate funds for the repair and/or replacement of all capital assets. All planned real estate community associations must now conduct reserve studies to ensure they have sufficient funds for maintaining and replacing all common area elements. These studies must be updated at least every five years. The reserve study must be performed by a CAI-accredited Reserve Specialist, and then the association must comply with a 30-year funding plan. LCPOA had these inspections performed by Kipcon, a CAI-accredited Reserve Specialist and licensed structural engineering firm, and received our reserve study plan (it is available to members online

at <a href="https://www.barrylakes.org">www.barrylakes.org</a>), which amounts to over \$10 Million! As a result, LCPOA must impose significant dues increases to comply with this 30-year funding plan mandated by the NJ Structural Integrity Act. Our 2026 annual budget

(including the necessary increases) will be presented to the membership for approval at the next General Meeting in October. At the General Meeting, members vote on approval of the budget. Of course, only members in good standing may attend the General Meetings and are entitled to vote.

Happy Summer, Everyone!
I'm pleased to share some great news—
pothole repairs have officially begun, and
additional paving work is underway. The
updated paving includes sections of Barry
Drive South, Pond, Jordan, Juniper, and the
dam access road off Lakeshore. This covers
approximately half a mile of roadway at a total
cost of \$95,000, which represents a significant
savings which I'm sure you're aware of from the
discussion at our recent General Meeting.
At this time, the entire road maintenance
budget has been allocated for the season.

A quick reminder: All drainage maintenance is the responsibility of individual homeowners, similar to sidewalk upkeep in city environments. Please ensure your property's drainage is properly maintained.

House Numbers Matter! I can't emphasize this enough—please make sure your house number is clearly visible. It's essential not just for deliveries (your Amazon driver will thank you!), but also for emergency services. A clearly marked address can make all the difference in critical moments.

I hope everyone is having a wonderful summer! All Board and General meeting held this year have been conducted according to our by-laws and PREDFDA rules.

Recently, there have been some questions regarding road drainage -

To clarify the position of the LCPOA for Road Drainage and related maintenance within the community roadways, the policies below were made to provide clear direction in the roles and responsibilities between the LCPOA and individual members.


- If a pipe currently exists underneath a driveway, it is the responsibility of the homeowner to maintain it and ensure the free flow of water through that pipe.
- Pipes that are used primarily for providing drainage across community roadways are the responsibility of the LCPOA. Most of these pipes are found at intersections and funnel the flow of water from one side of the road to the other.
- Maintaining Rip Rap / Swales is the responsibility of the homeowner. This includes such tasks as cutting the grass and removing debris, such as leaves, branches, or litter found in the swales.

#### SENIOR CITIZEN DUES DISCOUNT:

Members who are 62 years of age or older are eligible for a 10% discount on the dues You must provide the office with proof of age to receive the discount. (license or birth certificate). This discount shall not be applied if the account is currently receiving a 10% Veteran's Discount.

#### **VETERAN/ACTIVE SOLDIER DISCOUNT**

Members in good standing that are Veterans or active military shall be offered a ten (10%) percent discount on their yearly dues. Proof of service must be provided. This discount shall not be applied if the account is currently receiving a 10% Senior Citizen Discount.

<u>DUES PAYMENT:</u> The last Dues payment for 2025 is due on August 15th. This payment will receive a late fee if it is not received in the office or postmarked by September 1st.
